
Will it be 'perimeter North America'? China overtakes Mexico as point of focus for inspection of goods and visitors; highest percentage of North Americans choosing Chinese visitors to question in 18 years of tracking.





The Nanos North American Monitor is conducted by the Nanos Research Corporation, which is headquartered in Canada and operates both in Canada and the United States. Parallel questions on bi-national issues are tracked by means of a hybrid telephone and online random sample of Canadians in the month of June, and a random representative online sample of Americans conducted in the month of August.

Nanos conducted an RDD dual frame hybrid telephone and online survey of 1,055 Canadians, 18 years of age or older, between June 29<sup>th</sup> to 30<sup>th</sup>, 2023, and a non-probability, representative online survey of 1,269 Americans between August 5<sup>th</sup> to 10<sup>th</sup>, 2023.

## **Key Findings**

#### CHINA TOP PRIORITY FOR INSPECTION OF GOOD AND VISITORS

Canadians and Americans agree that China is the greatest priority for inspecting goods (63% of Canadians, 53% of Americans). North Americans also chose Chinese visitors to be questioned most thoroughly, the highest percentage from both countries in all 18 years of tracking. Canadians say Chinese visitors should be questioned most thoroughly (65%), as Americans agree, now saying visitors from China should be questioned more thoroughly (46% in 2023, 34% in 2022), surpassing previous response of Mexico which now drops to second (33% in 2023 from 39% in 2022).

# AMERICAN APPETITE FOR ENERGY COOPERATION WITH CANADA LESS INTENSE WHILE CANADIAN APPETITE HITS NEW HIGH

While a majority of Canadians and Americans continue to rate the creation of an integrated energy policy to remove any dependence on Middle Eastern oil as very (Americans 47%; Canadians 59%) or somewhat important (Americans 36%; Canadians 29%). Canada hit an 18-year high in those who say it is very important (59%) while America dropped to an 18-year low in rating a joint energy policy as very important (47%), a difference of over ten percent of the respective countries' populations.




#### CONTINUING TRENDS IN CANADIAN-AMERICAN BUSINESS VALUES

Majority of Canadians rank the United States as closest with Canada in terms of business values (59%), an eight-year high, increasing steadily since the start of the Biden administration in 2021, following the rapid decline during the Trump administration from 2017-2020. Over one in four Americans also rated Canada as the closest with America in terms of business values with (27%), with Britain in a close second position (24%), a three-year low with a consistent decrease since the start of the Biden administration.








### Canadians and Americans on following their own interests


# **Closest Country in Terms of Values**

Under the Trump administration, Canadians were much less likely to say the U.S. was the country closest to Canada on business values. During the Biden administration, that has risen over 20 percentage points, now leading the U.K by almost 40 percentage points.



















The Nanos North American Monitor is conducted by the Nanos Research Corporation, which is headquartered in Canada and operates both in Canada and the United States. Parallel questions on bi-national issues are tracked by means of a hybrid telephone and online random sample of Canadians in the month of June, and a random representative online sample of Americans conducted in the month of August.

Nanos conducted an RDD dual frame (land- and cell-lines) hybrid telephone and online random survey of 1,055 Canadians, 18 years of age or older, between June 29<sup>th</sup> and 30<sup>th</sup>, 2023, as part of an omnibus survey. Participants were randomly recruited by telephone using live agents and administered a survey online. The sample included both land- and cell-lines across Canada. The results were statistically checked and weighted by age and gender using the latest Census information and the sample is geographically stratified to be representative of Canada.

Nanos conducted an online non-probability survey of 1,269 Americans, representative of the U.S. population, 18 years of age or older, on August 5<sup>th</sup> to 10<sup>th</sup>, 2023 as part of an omnibus survey. Participants were randomly recruited by telephone using live agents and administered a survey online. The results were statistically checked and weighted using the latest Census results to be representative of the American population. The U.S. study was a representative non-probability survey weighted to reflect the U.S. population

The research was commissioned by Nanos Research and the Norman Paterson School of International Affairs and was conducted by Nanos Research.
