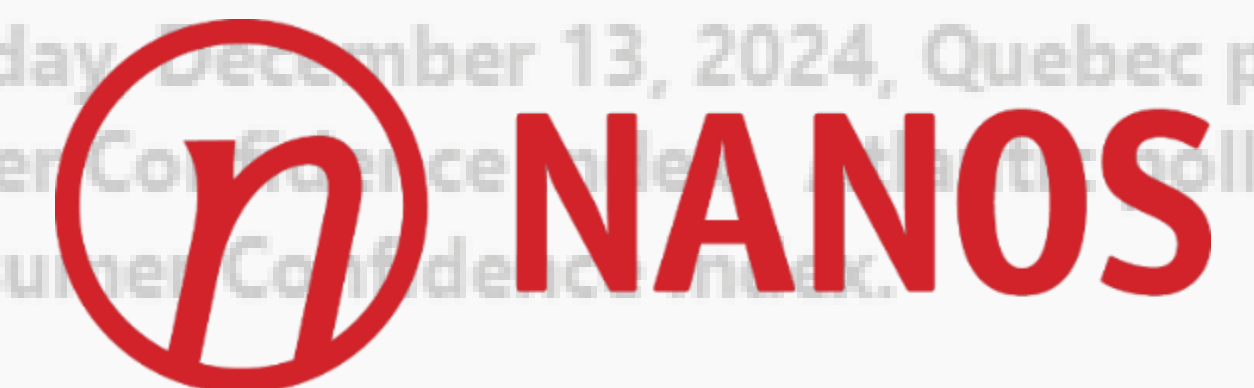

Nanos Economic, Issue & Sentiment (EIS) Tracking Portal – At a Glance

Access thousands of trend lines, with over 100 questions across seven thematic data areas. The data can be filtered by region, age and gender and is organized by the following themes:

Consumer Confidence – updated weekly, with historical data since 2008: A proven leading indicator of future GDP, track the Bloomberg-Nanos Consumer Confidence Index, the Expectations Index, the Pocketbook Index, with questions related to the performance of the Canadian economy, job security, personal finance, and projected real estate values.

Domestic Policy – updated yearly, with historical data since 2015: Tracking Canadians’ responses on a wide variety of public policy issues, their importance to Canada’s future, and respondents’ confidence levels in finding solutions to important issues.

Canada-US Relations – updated yearly, with historical data since 2005: Tracking Canadians’ and Americans’ views on various countries’ human rights and business values, as well as which nations they would like customs officials to view with more scrutiny. The Canada-US Relations section of the Sentiment Portal also tracks the level of cooperation Canadians and Americans want to see regarding issues such as national security, border security, anti-terrorism, and removing dependency on Middle East oil. Tracking of Americans and Canadians on perception related to Canada, the US, Mexico, China, Japan, Germany France and the UK.

State of Democracy : tracking Canadians’ feelings toward the federal government (updated quarterly, with historical data since 2018), their satisfaction with Canada as a country, and their opinions on eleven public and private-sector institutions in Canada (updated yearly, with historical data since 2021).

Foreign Relations – updated yearly, with historical data since 2019: Tracking Canadians’ views on relationships with China, France, Germany, the UK and the US, their opinion on NATO, their level of comfort with the US, Germany, Russia, Middle Eastern countries, Australia and China as energy partners, their level of comfort with the US, Europe, Asia and Africa as partners in terms of having a positive relationship that benefits Canada and their ideal level of cooperation between Canada and Europe in higher education, on security issues and on matters of trade and prosperity.

Wellness – updated yearly, with historical data since 2020: Tracking respondents’ alcohol consumption since the pandemic began, concern about their drinking habits, concern about their mental health, the state of their mental health, and how they are coping with self-isolation measures (note: tracking on self-isolation measures includes data from 2020 to 2022).

Issue Tracking – updated weekly, with historical data since 2015: Tracking Canadians’ most important national issue of concern.

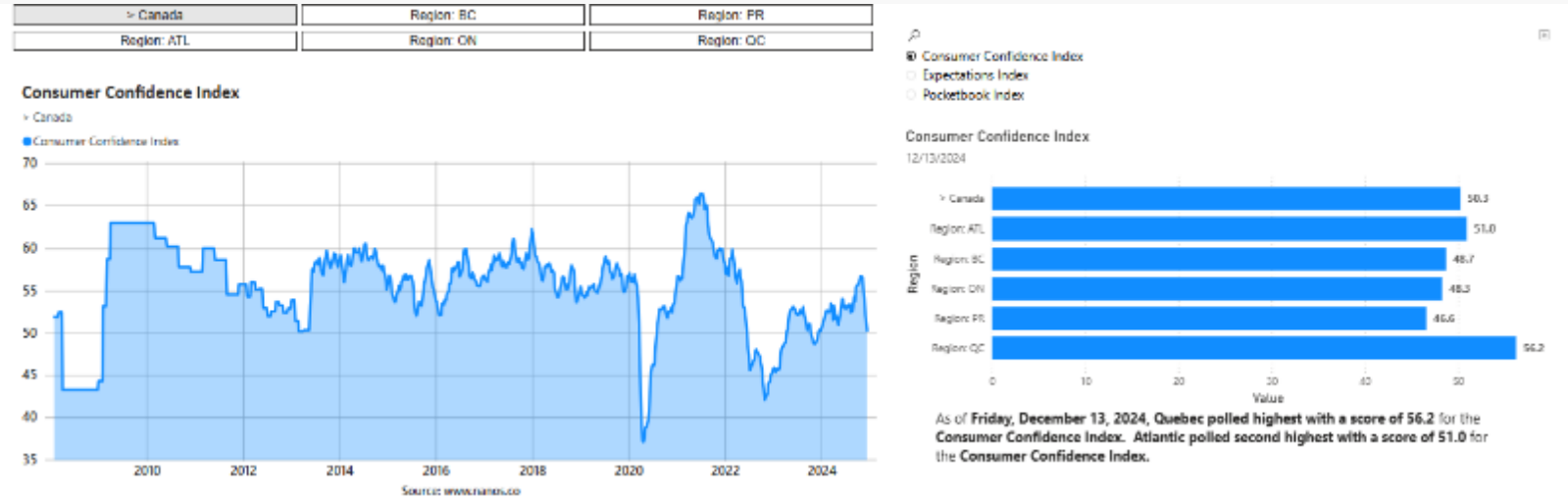
The indices above are built based on respondents’ answers to questions on the value of real estate, their perceived job security, their projections for future performance of the Canadian economy, and their personal finances. These questions, which, like the indices themselves, can be viewed by respondents’ region, age, and gender, are as follows:

2. Would you describe your job, at this time, as secure, somewhat secure, somewhat not secure or not at all secure?
3. Thinking of your personal finances, are you better off, worse off or has there been no change over the past year?
4. In the next six months, do you believe that the value of real estate in your neighborhood will increase, stay the same or decrease?

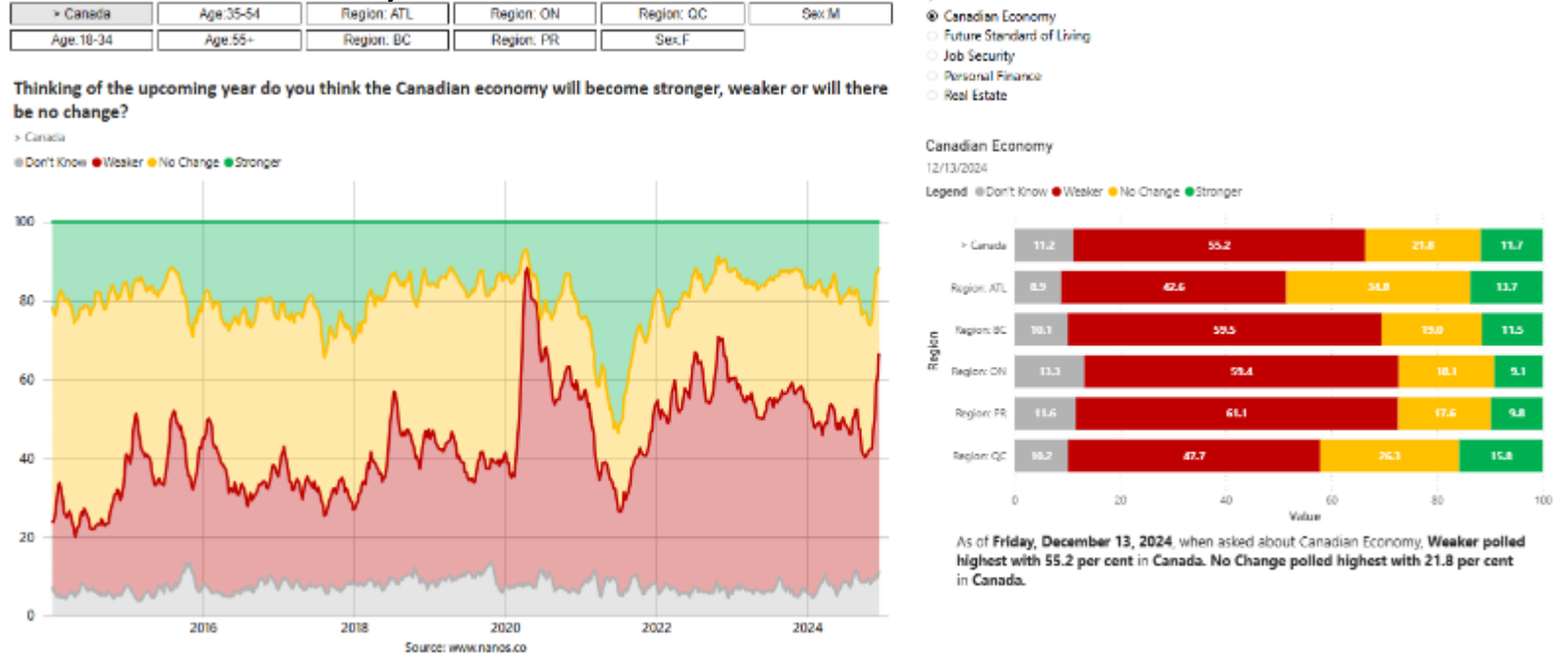

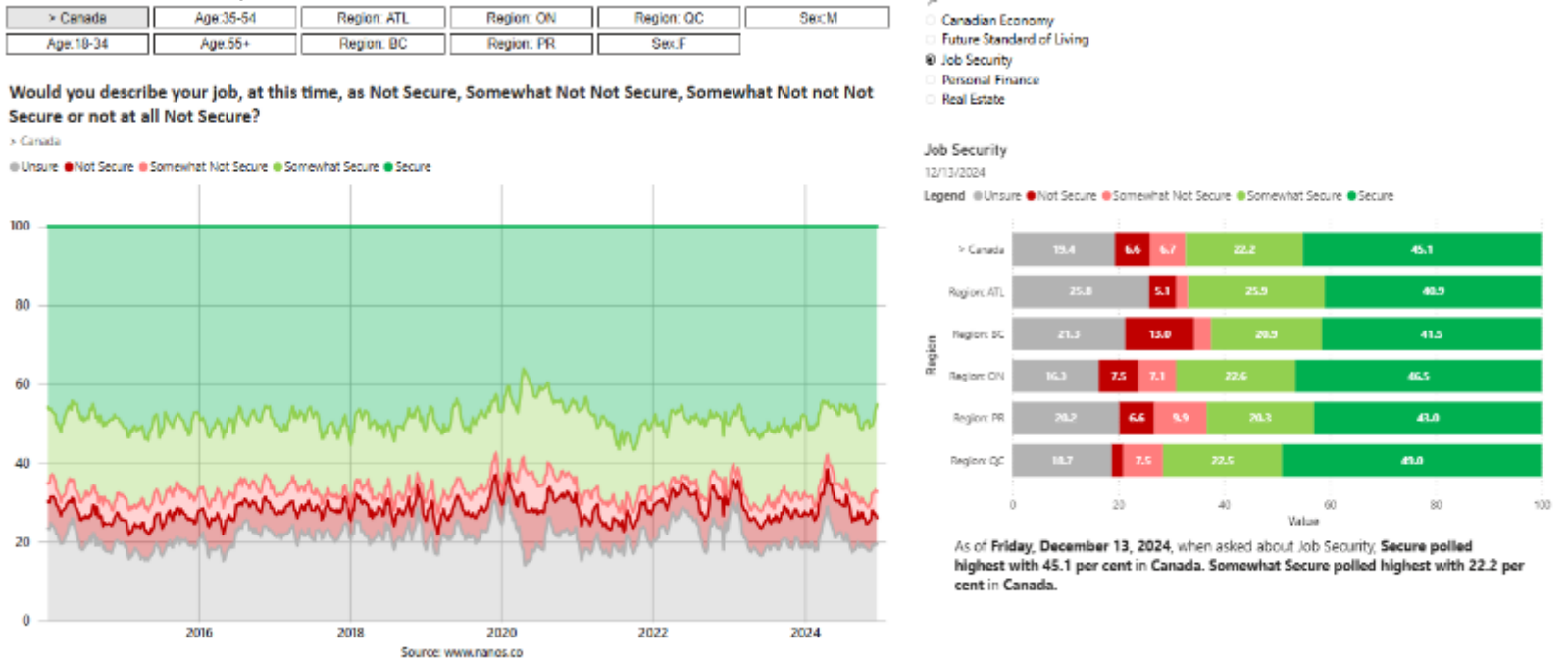
Consumer Confidence Index

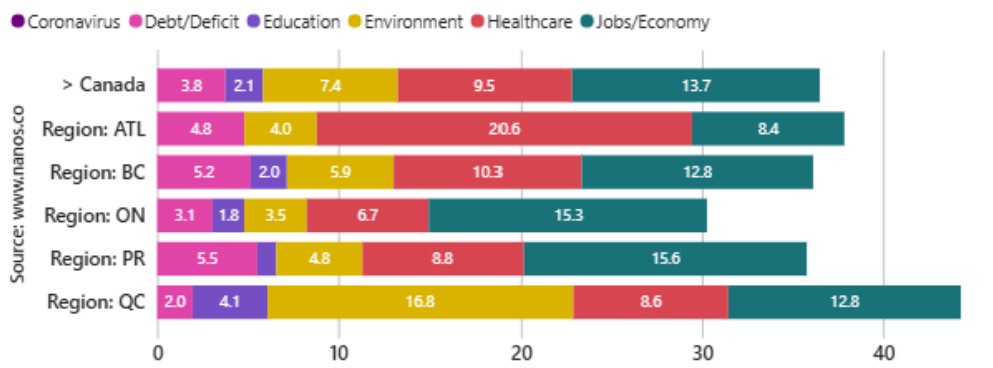
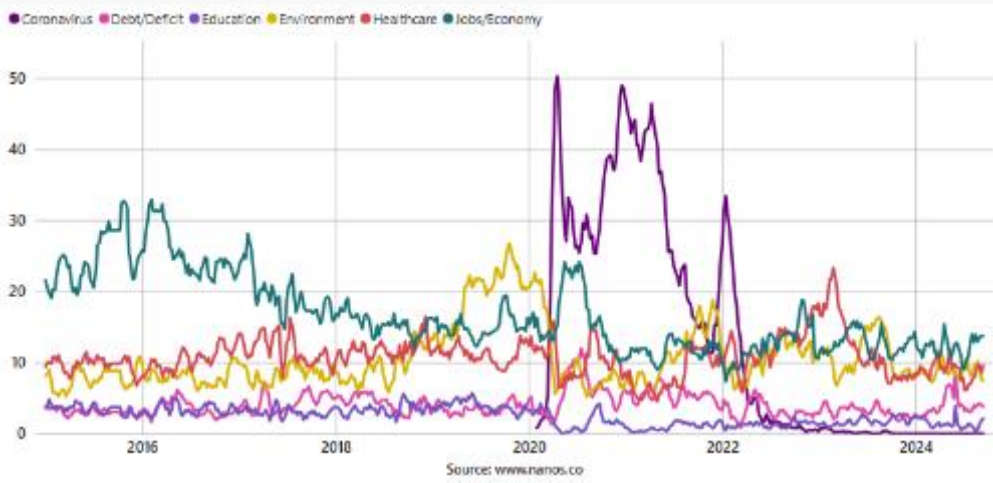


Issue Tracking

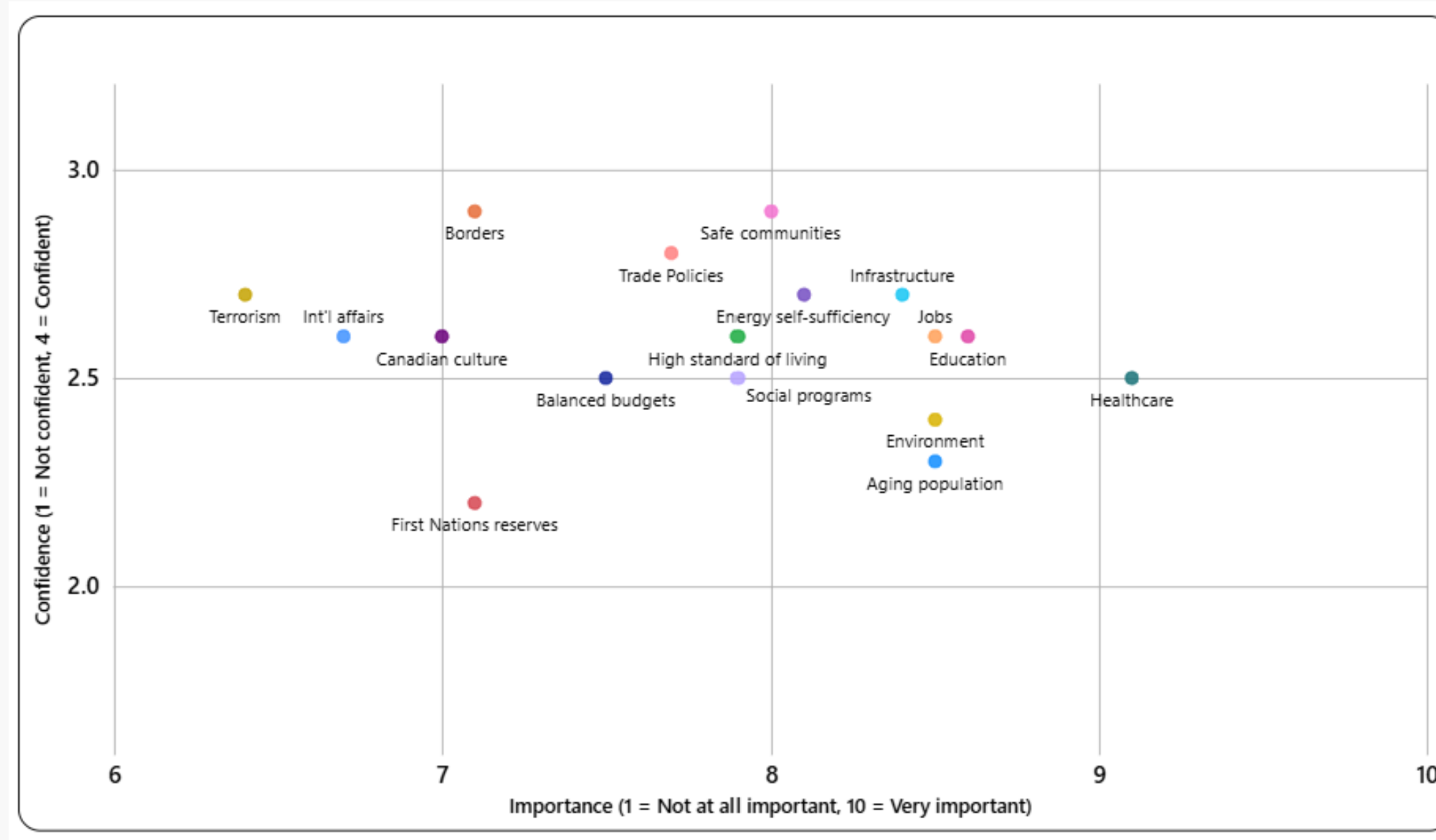

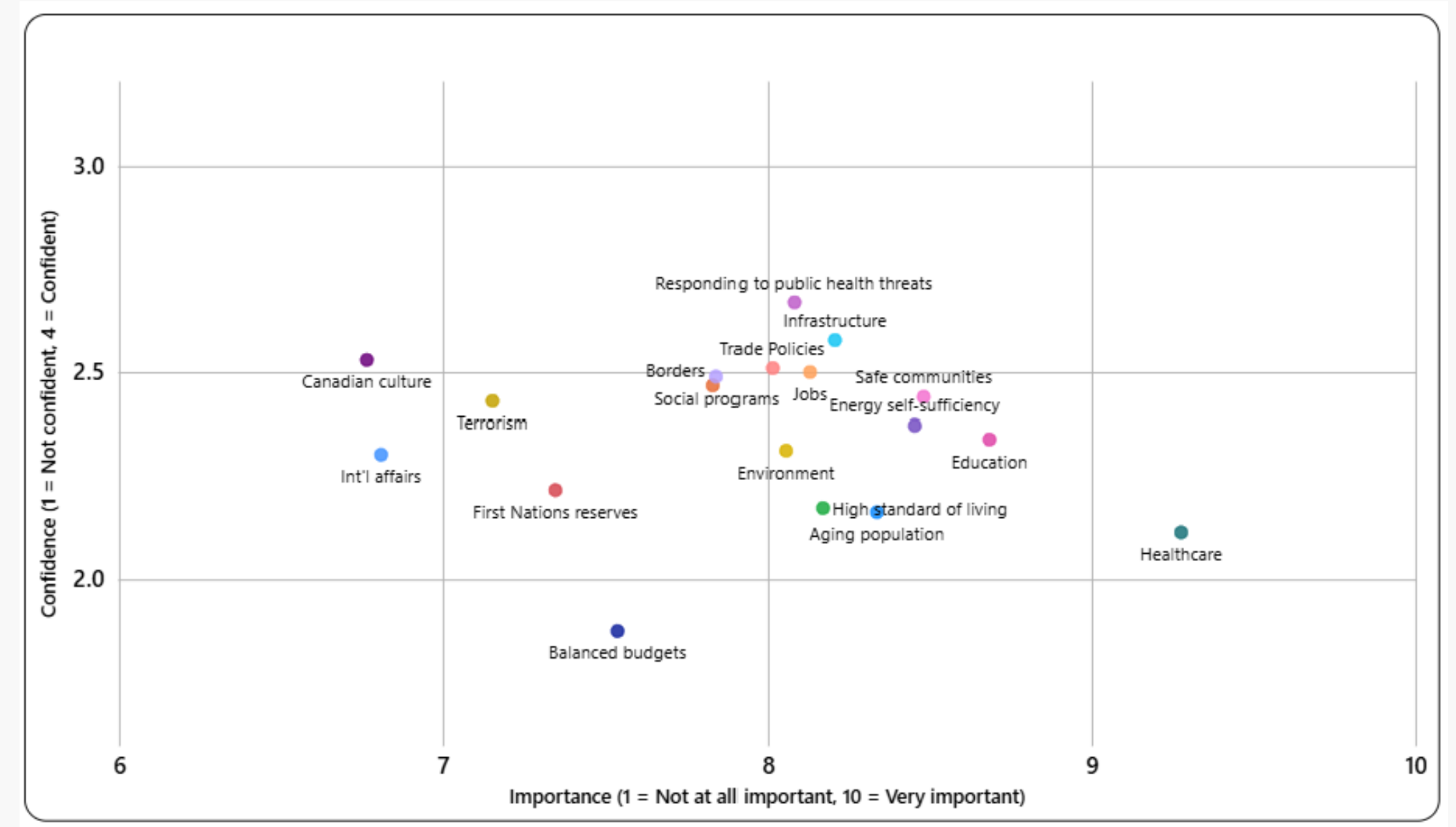

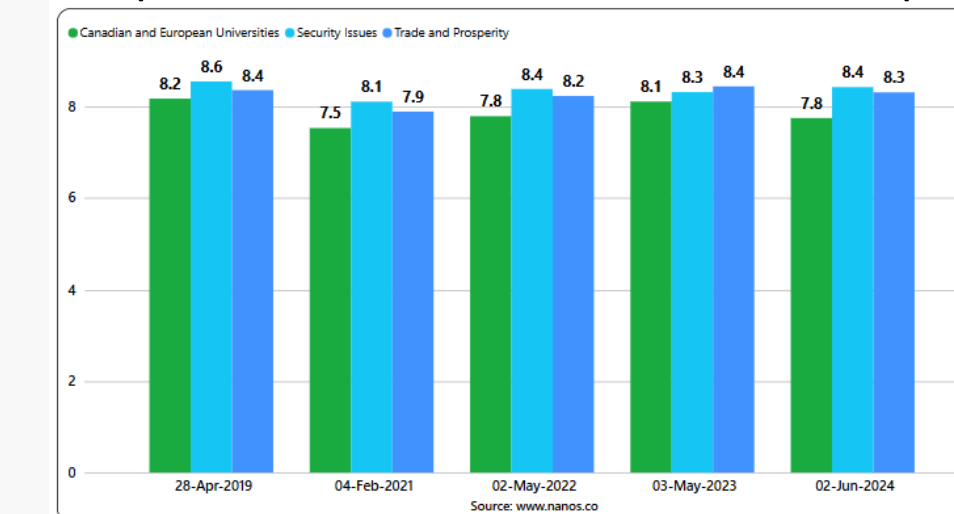

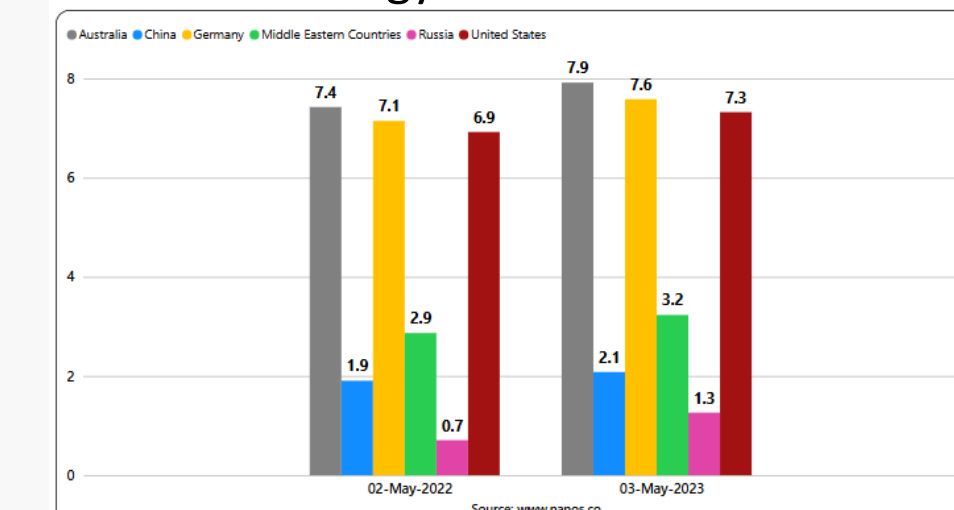

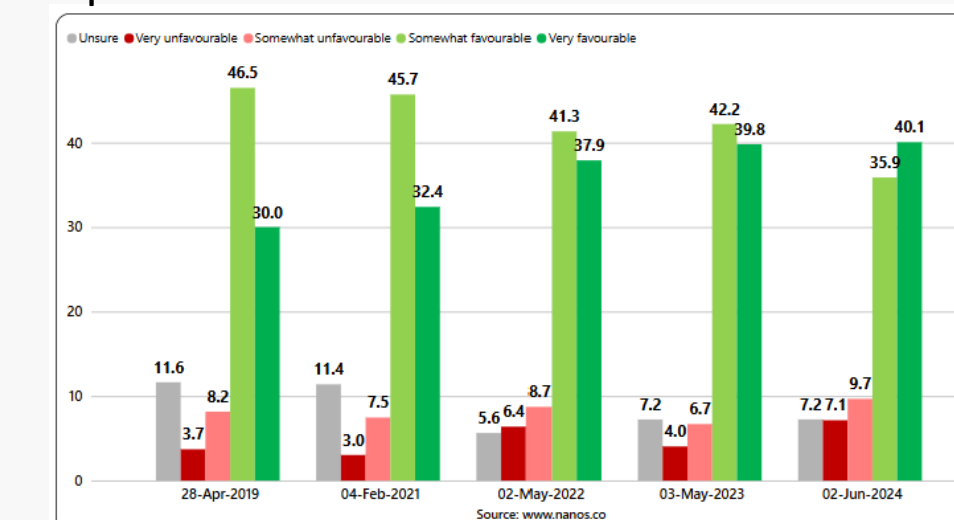

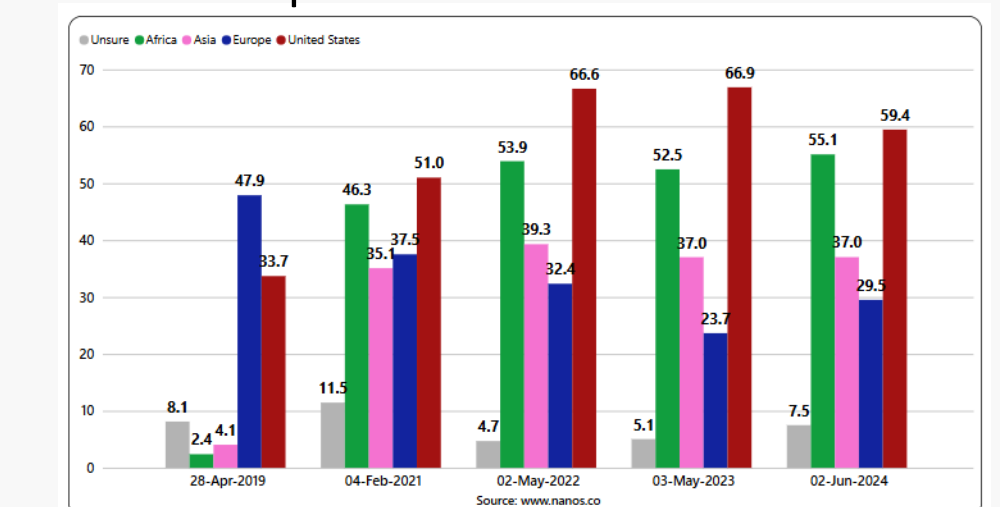
Nations as Energy Partners



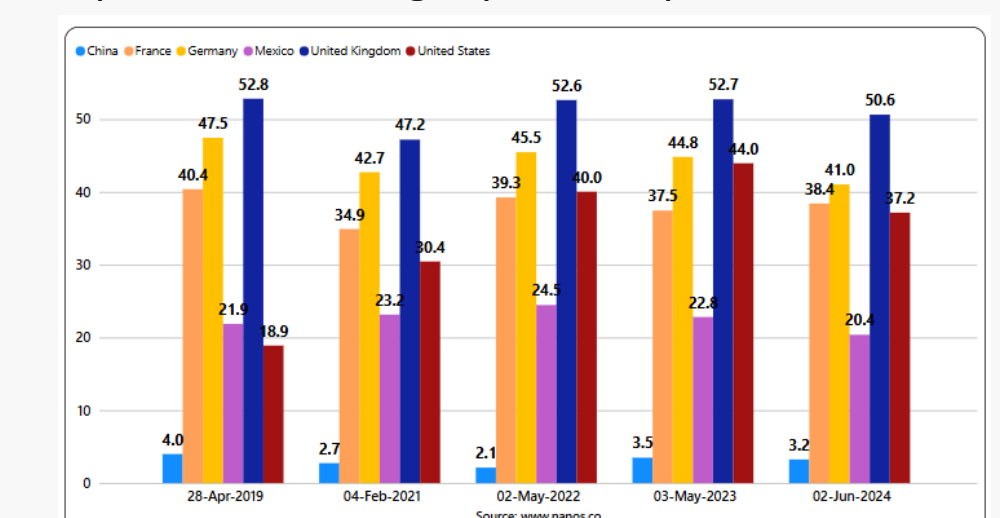
Opinion on NATO

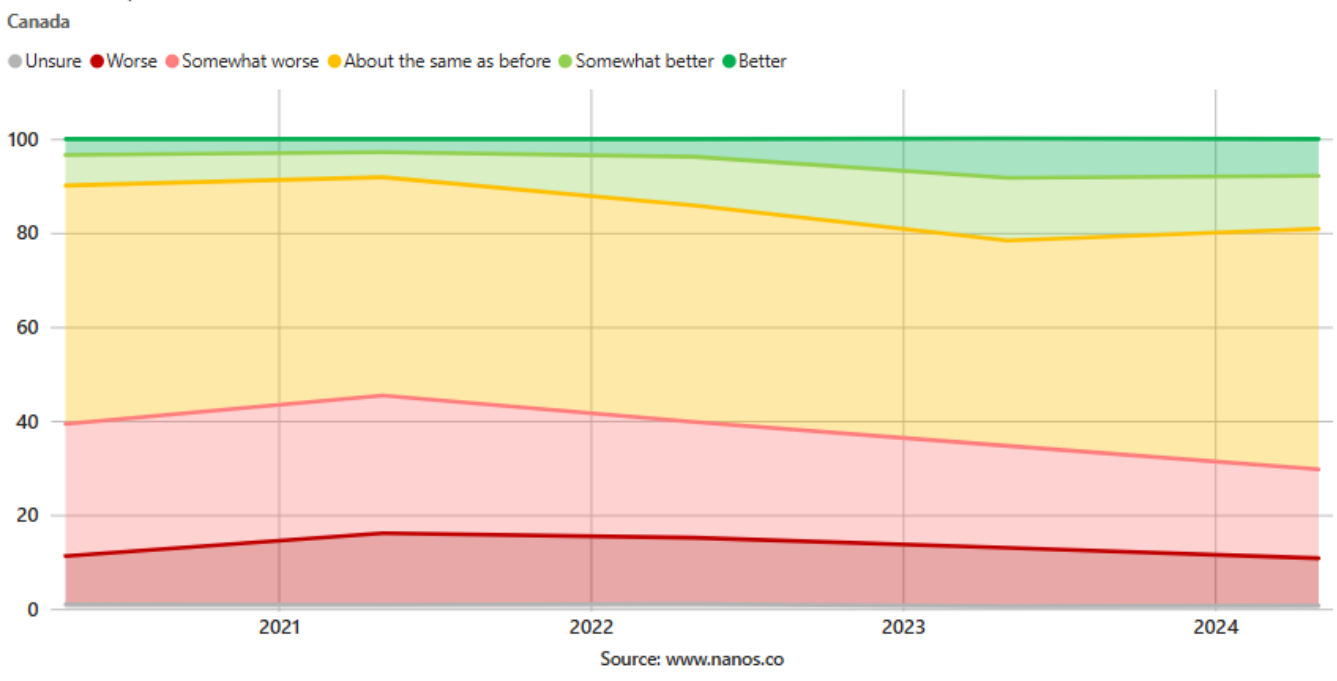
Wellness

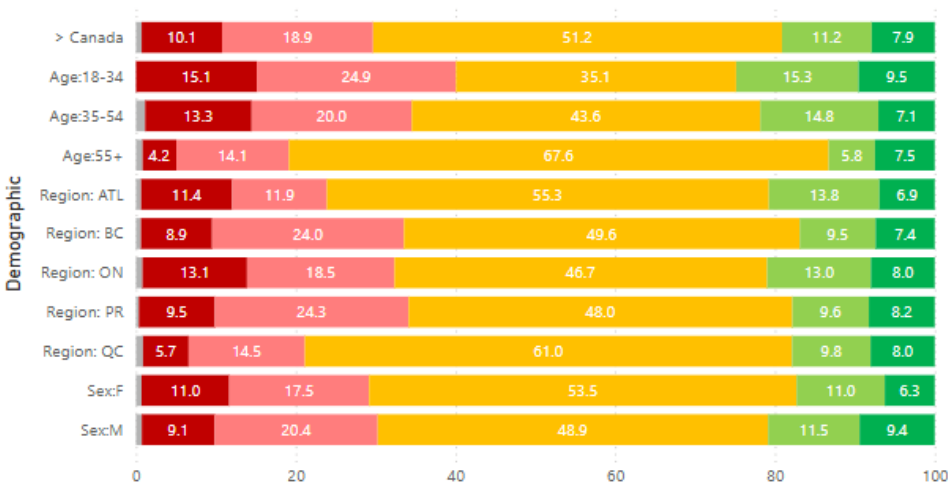

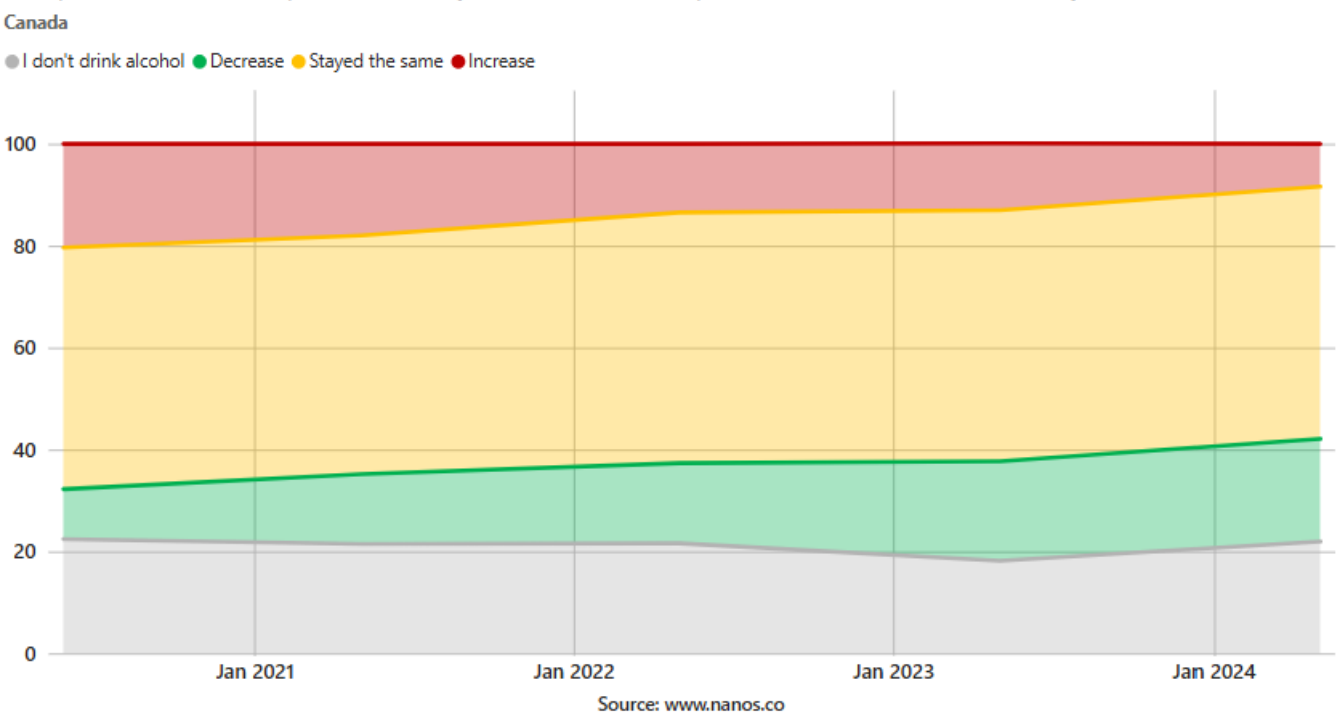

Alcohol consumption

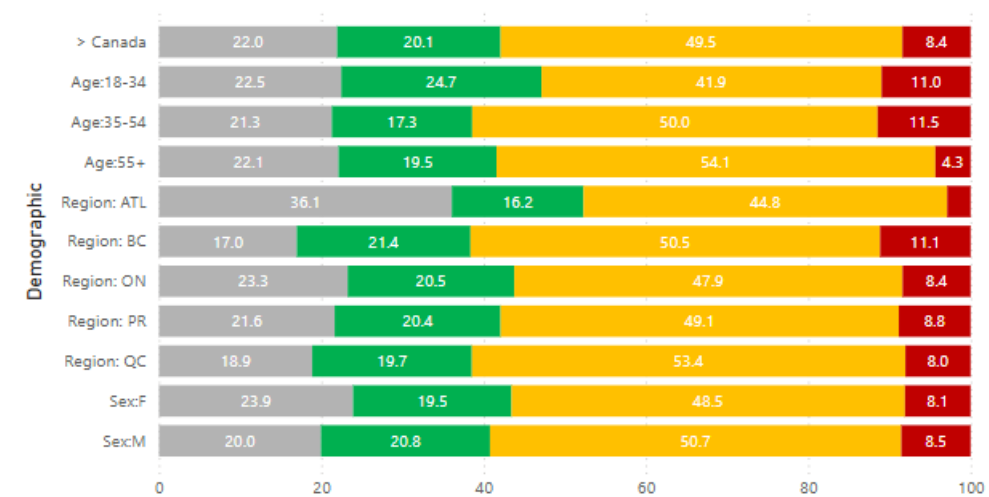
Compared to before the pandemic, has your alcohol consumption increased, decreased or stayed the same?

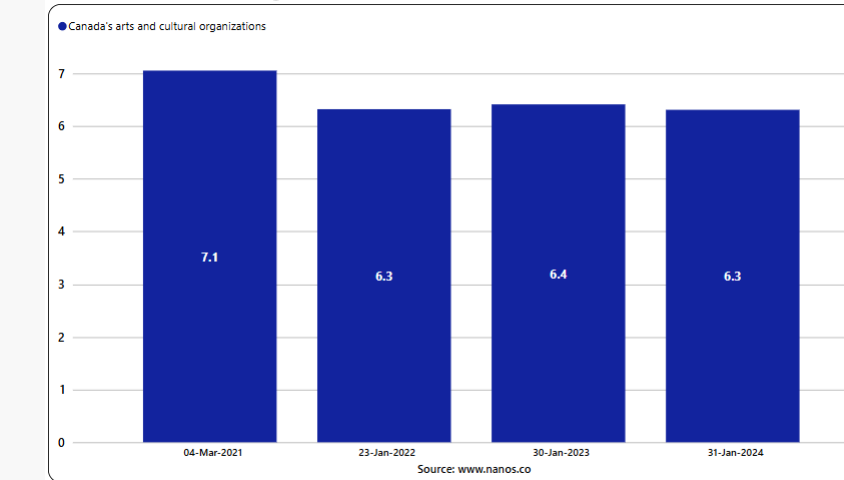

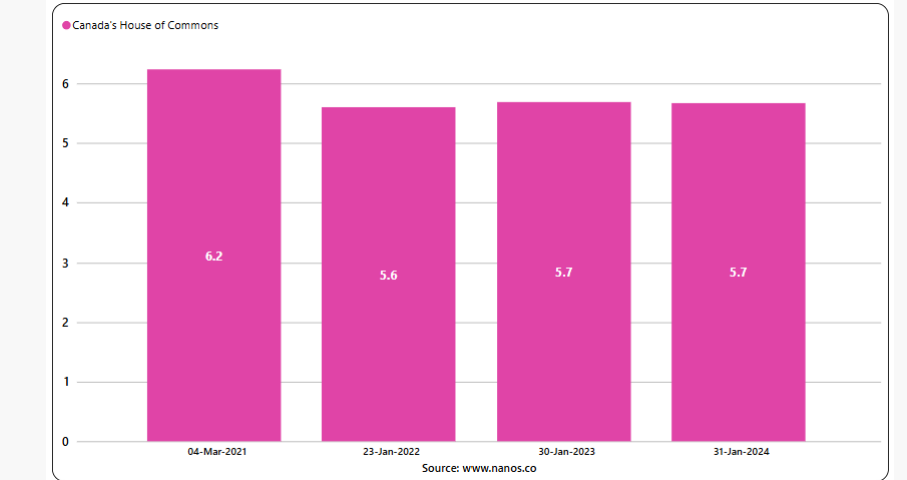

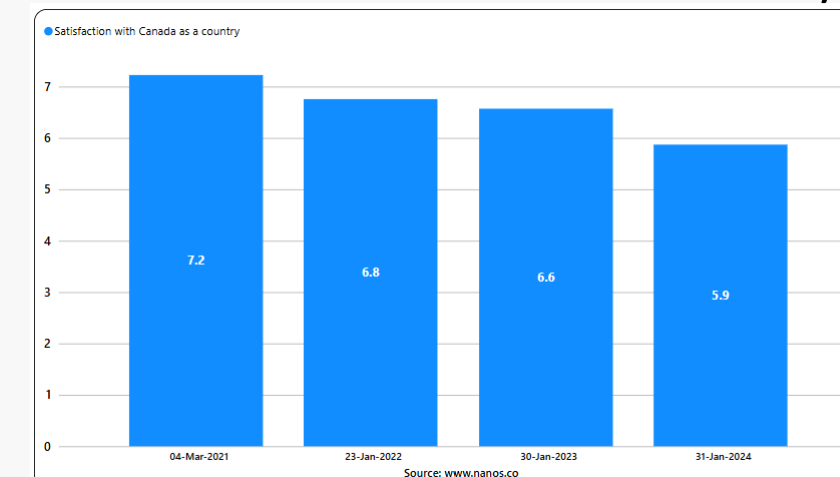

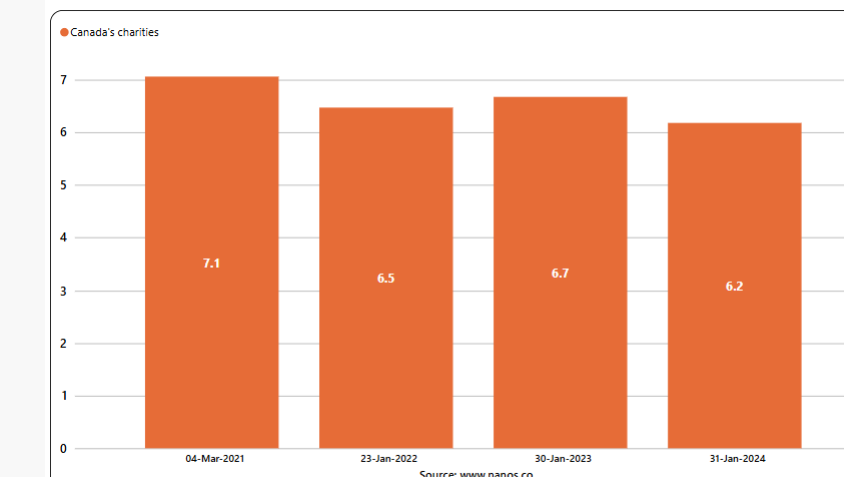
Contribution to Canada – House of Commons



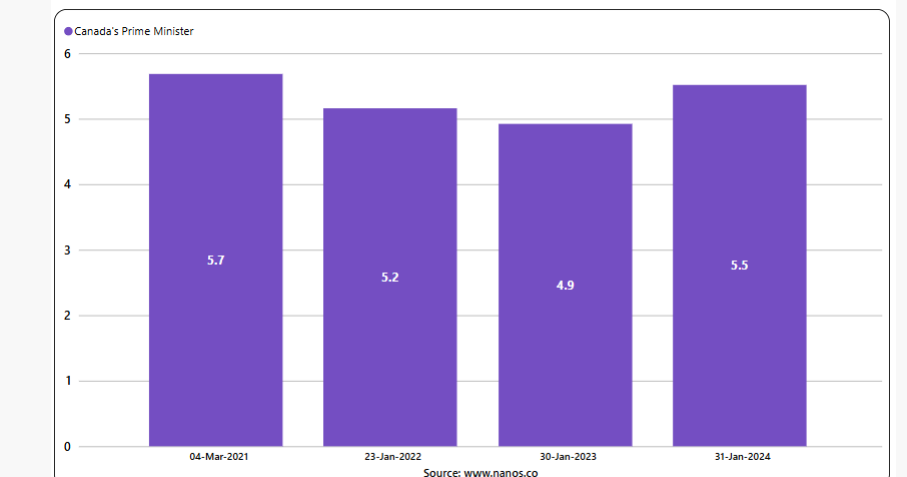
Satisfaction with Canada as a country



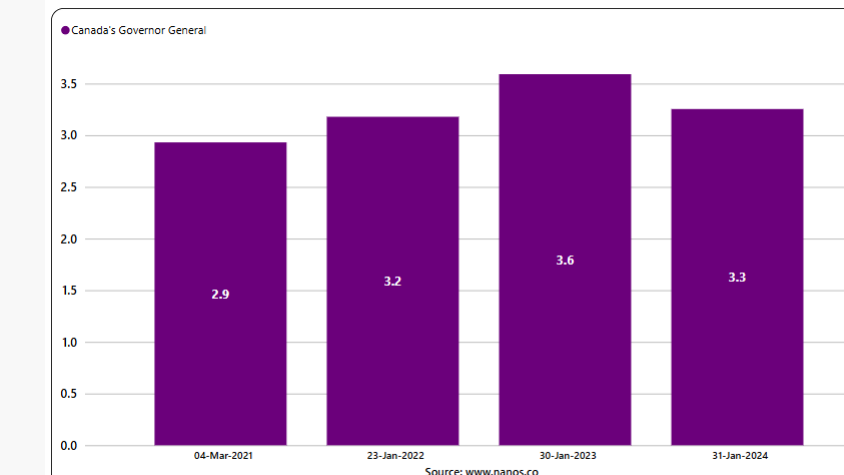

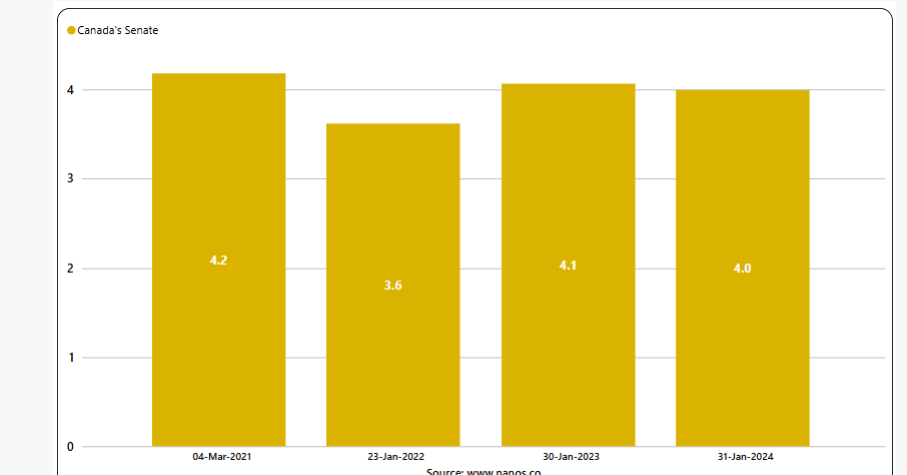

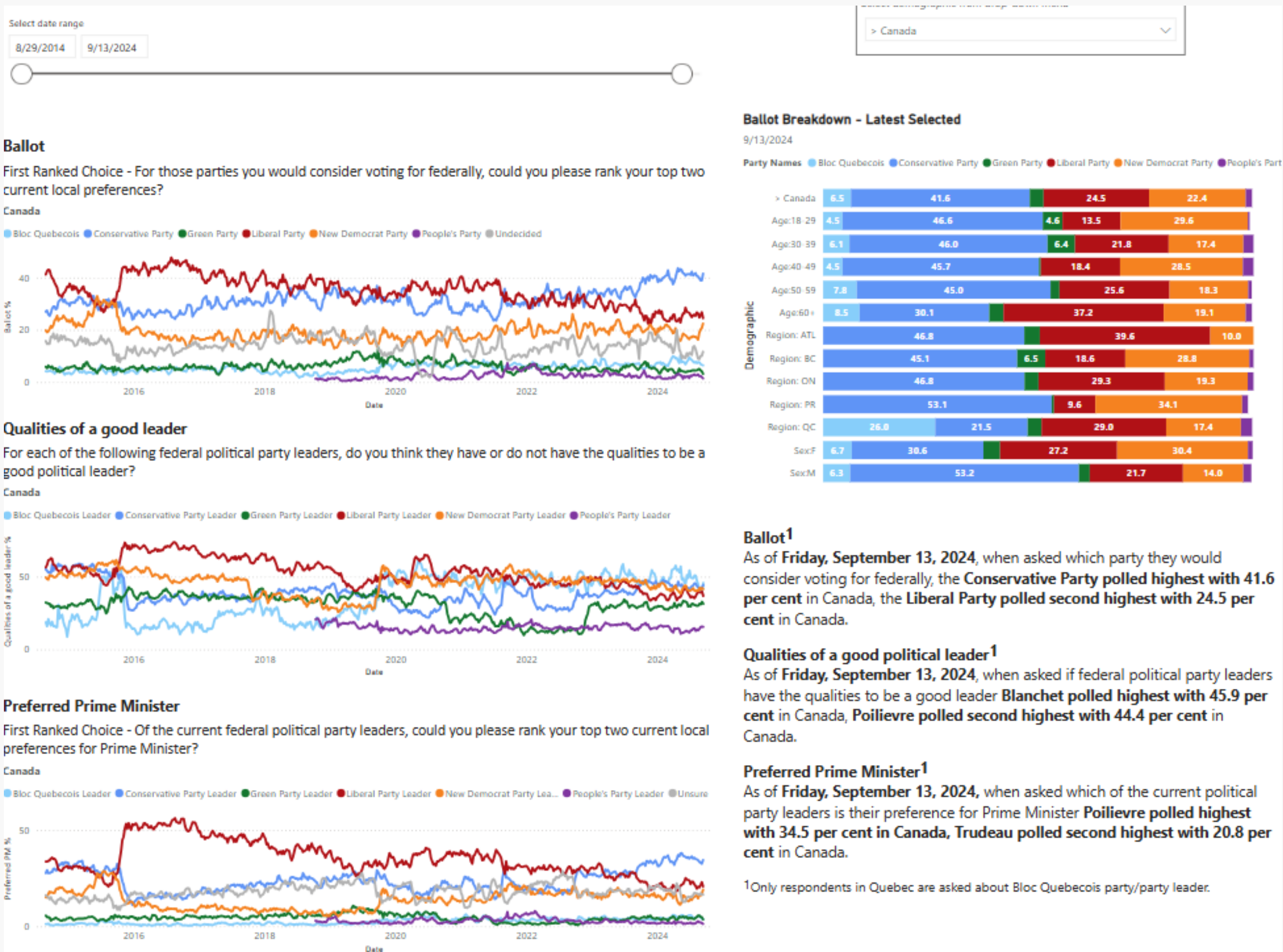

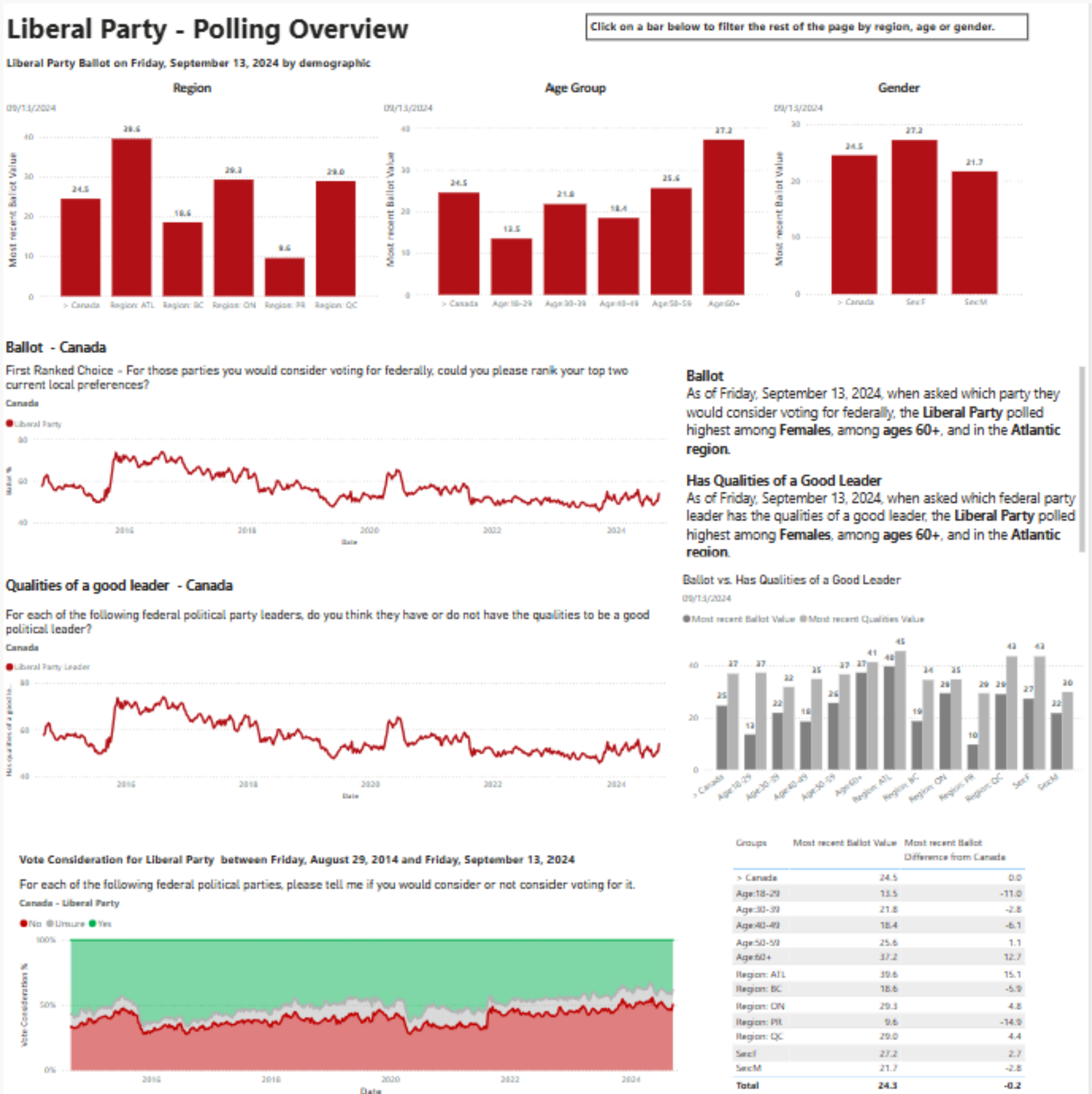
1-year Party Trend, Election Tracking, Power Index & Custom Charts

The 1-year Party Trend section neatly organizes the ballot question with first ranked vote preferences for each federal party region, age and gender.

The Election Tracking section of the Nanos Federal Political Tracking Portal contains weekly historical data leading up to the 2015, 2019 and 2021 Canadian Federal elections. In this section, you can view daily updates for ballot tracking, Party Power Index, preferred primer minister, vote consideration and qualities of a good leader questions in the weeks leading up to each of the last three the federal elections.

Since voters are not actually able to make a choice between elections, it is interesting to think about party strength and support more broadly. The Nanos Party Power Index fills this need by incorporating more information than just current vote preference. The Nanos Party Power Index is a weekly composite measurement of federal party brands based on four questions about the federal parties and their leadership. The questions include:

- A ballot question that captures the 1st and 2nd vote preferences;
- A measure of whether the respondent would consider voting for the party;
- The 1st and 2nd preferences for Prime Minister of the current federal leaders; and,
- Whether the respondent believes each current leader has the quality to be a good leader.

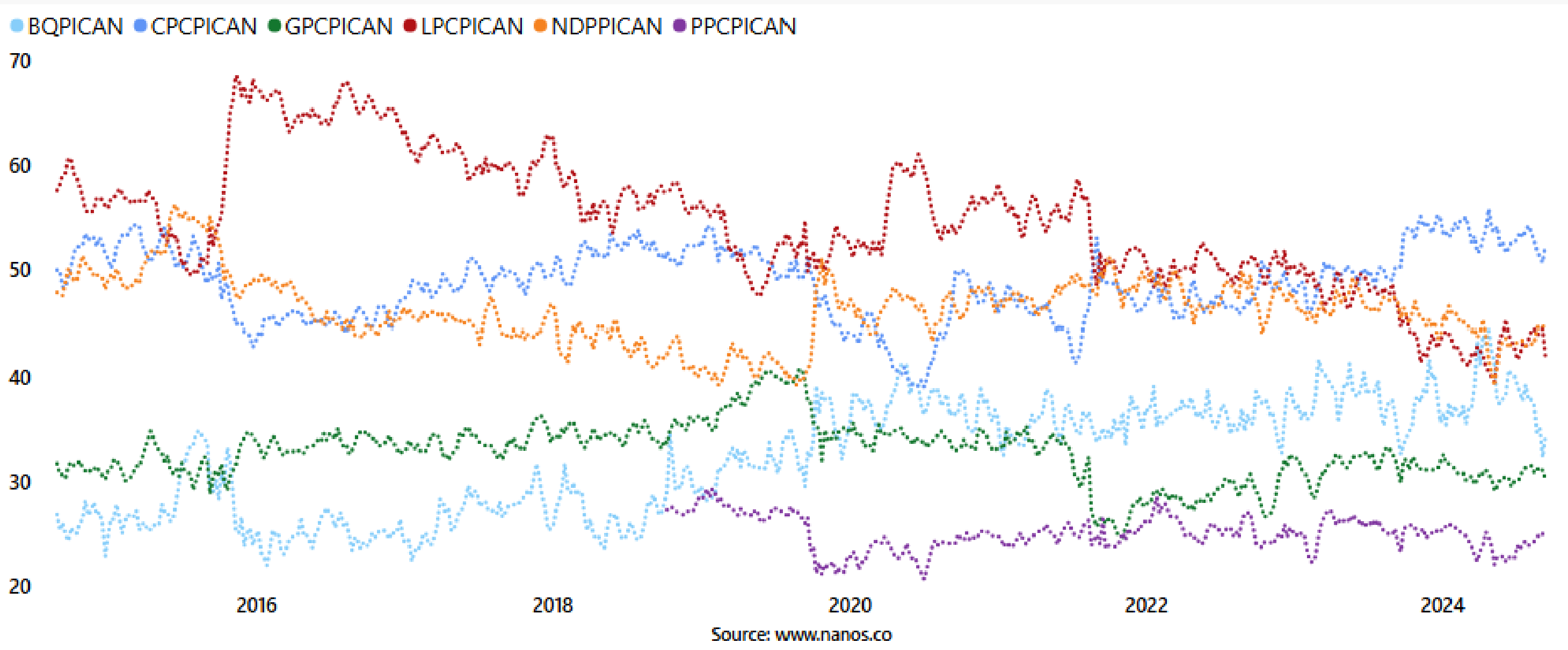

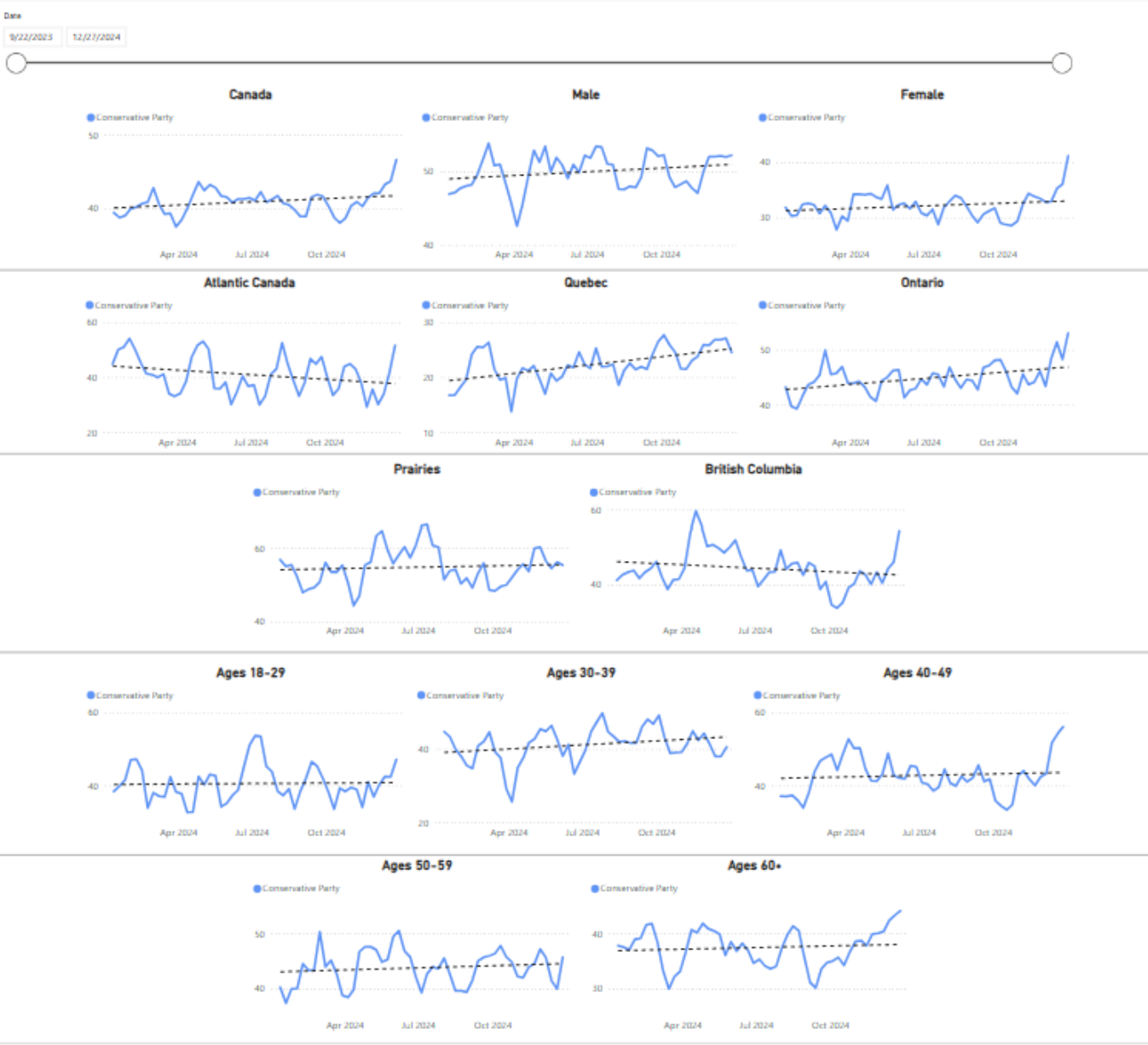

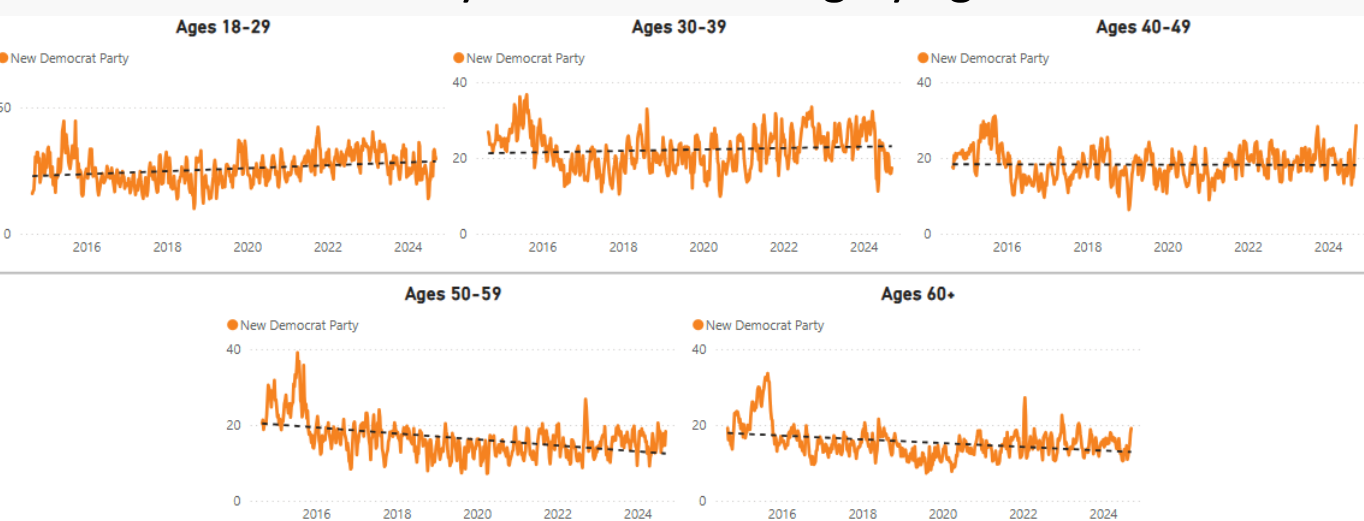
Nanos Party Power Index



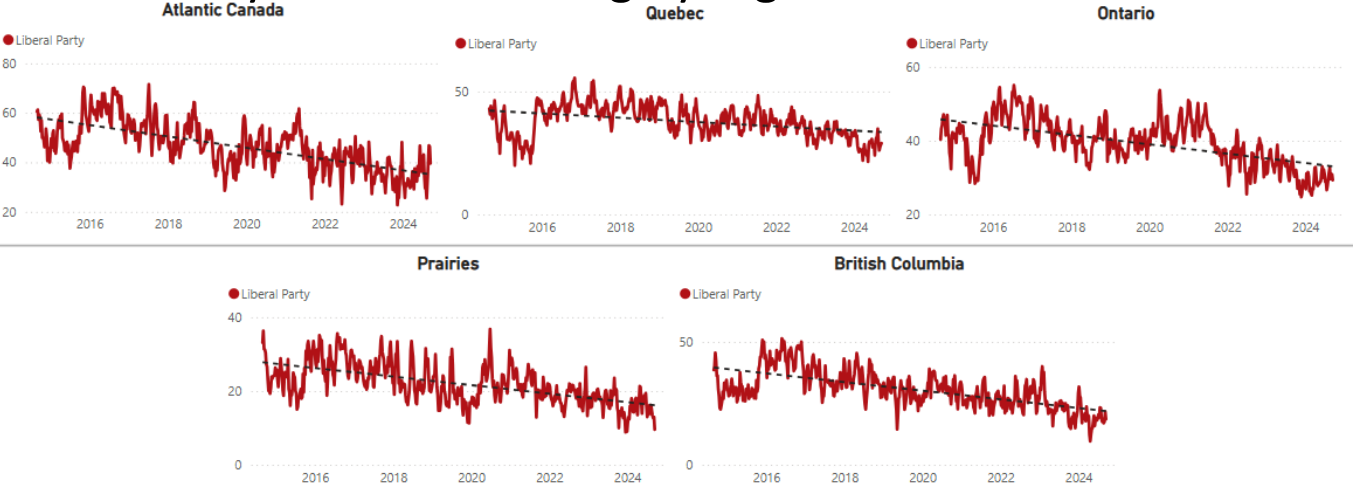
Conservative Party – Ballot Tracking by region, age and gender



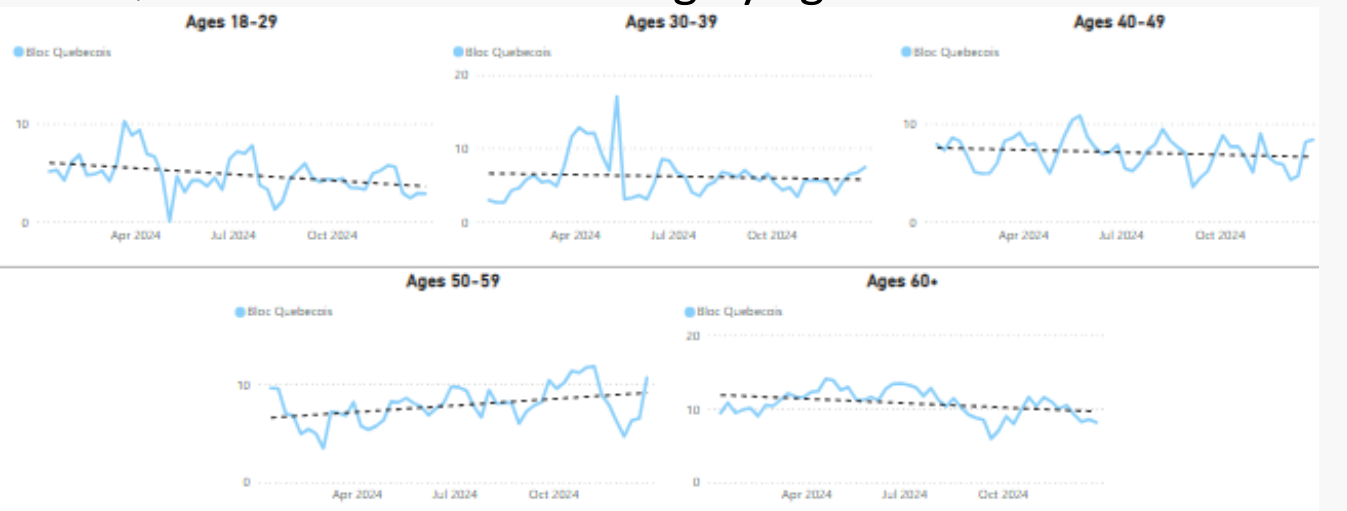
New Democratic Party – Ballot Tracking by age

Bloc Quebecois – Ballot Tracking by age

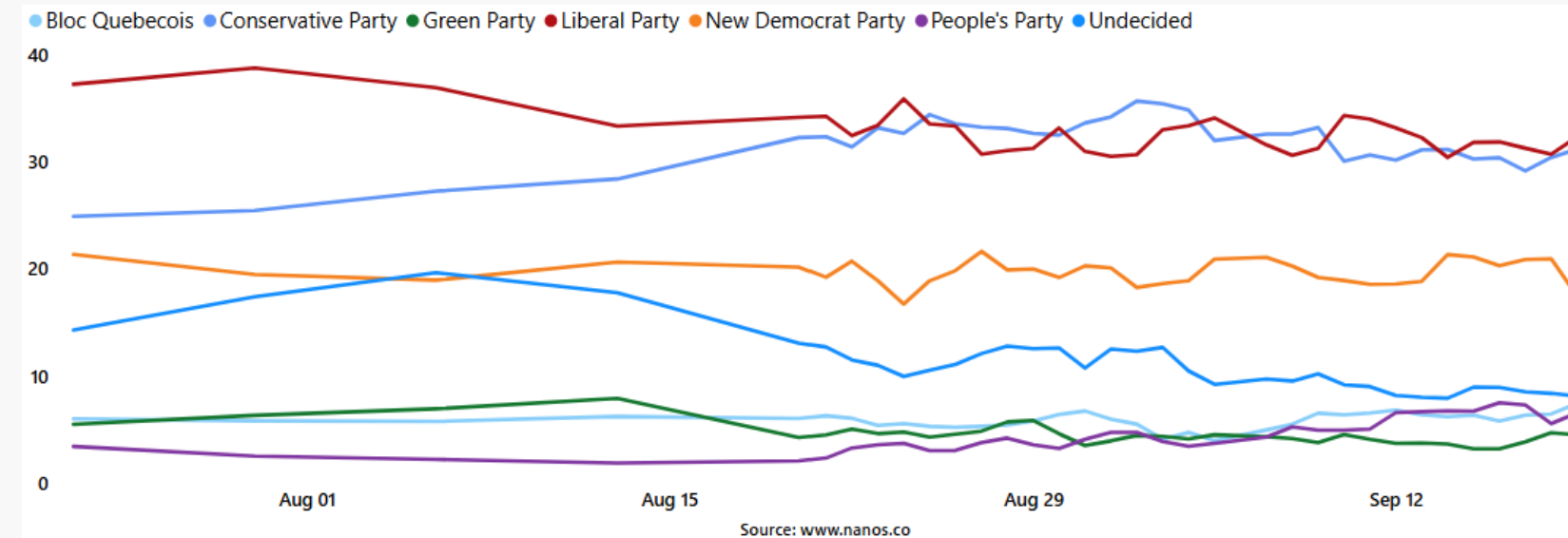

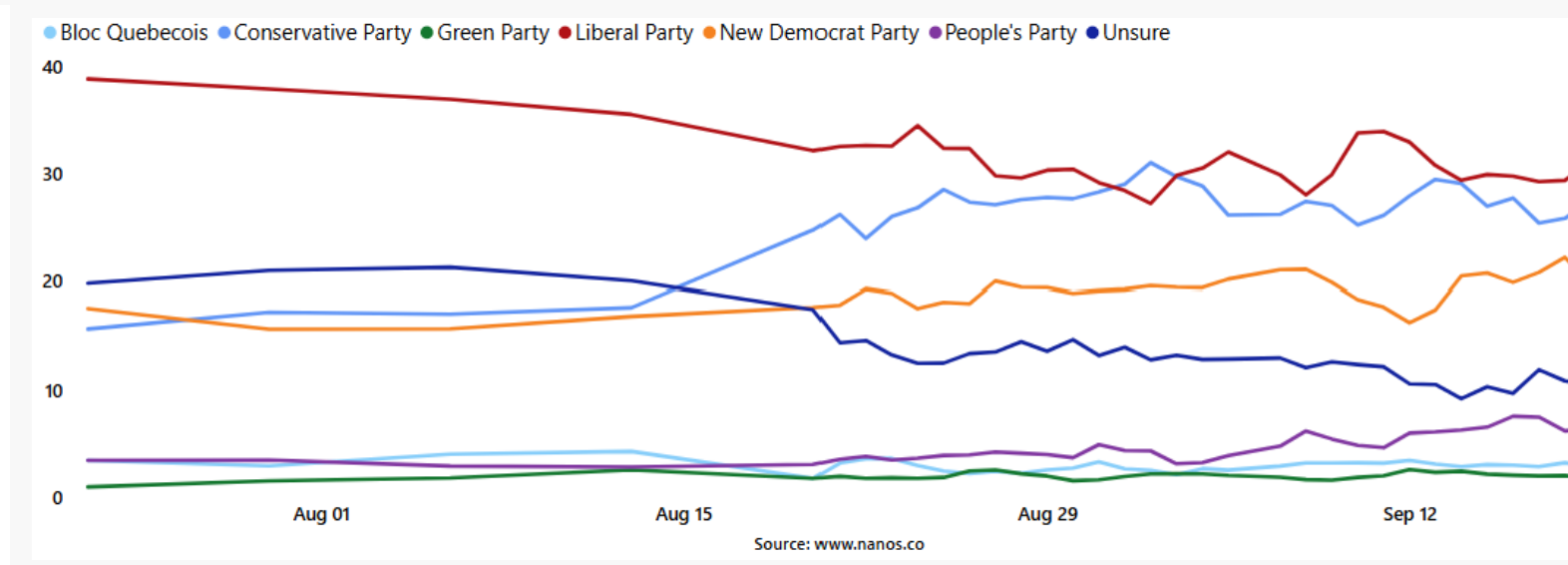

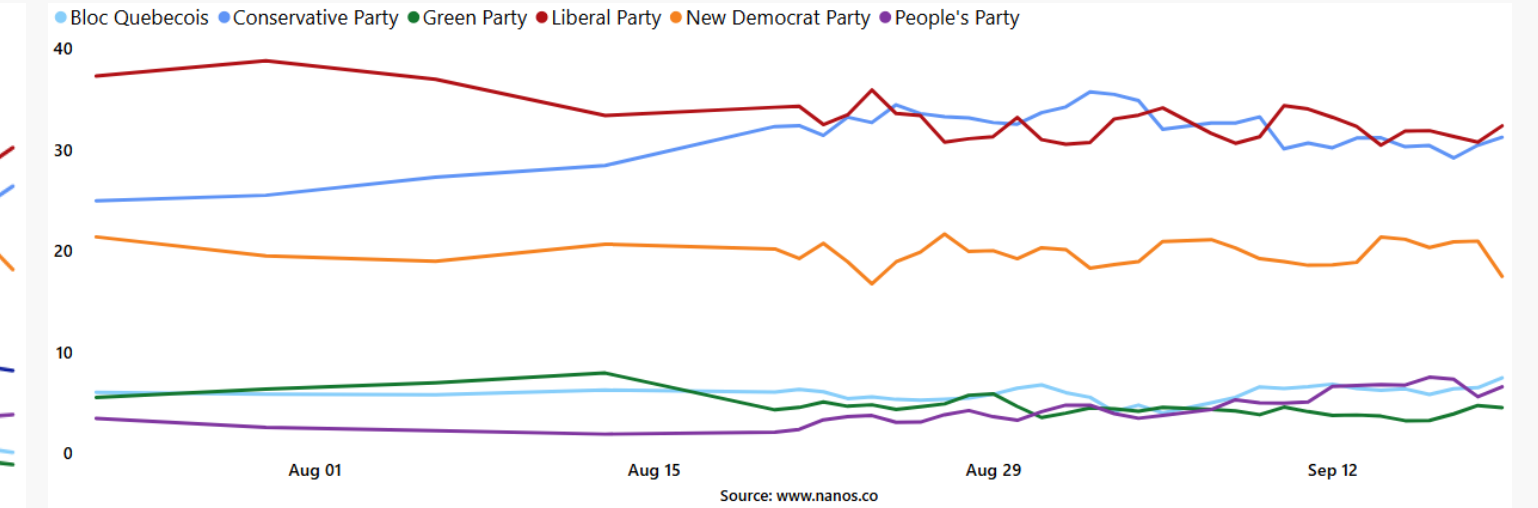
2021 Election – Nightly ballot tracking



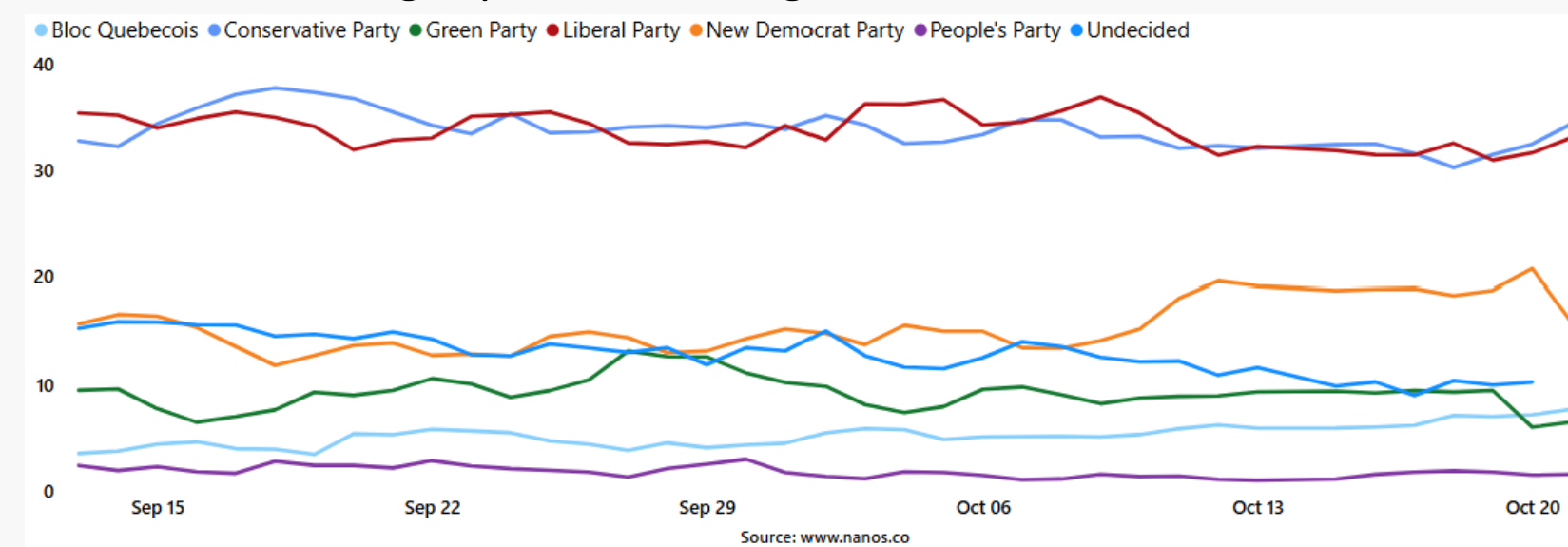
2021 Election – Nightly Preferred Prime Minister tracking



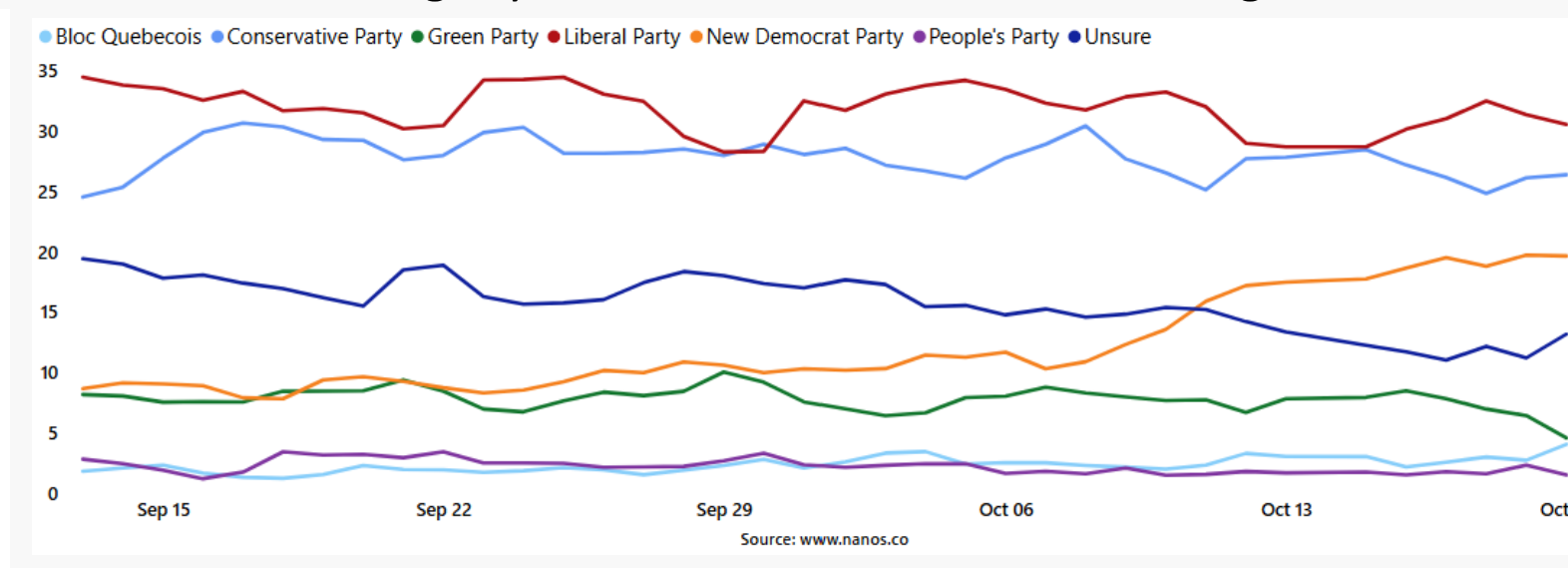
2021 Election – Nightly Party Power Index tracking



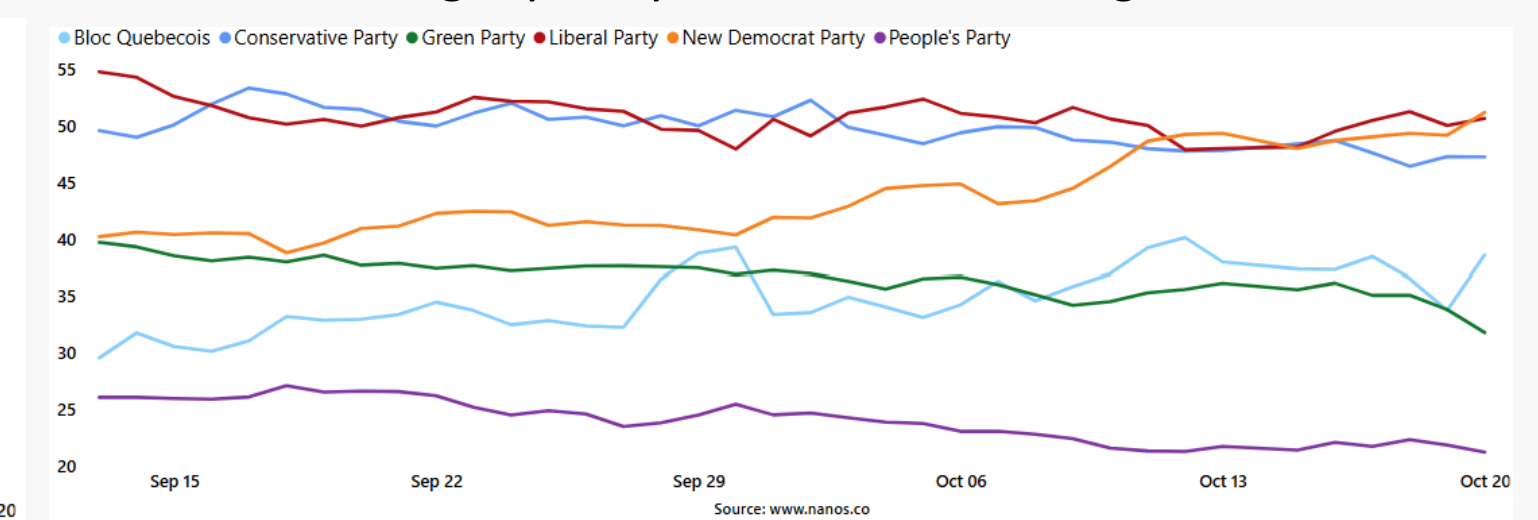

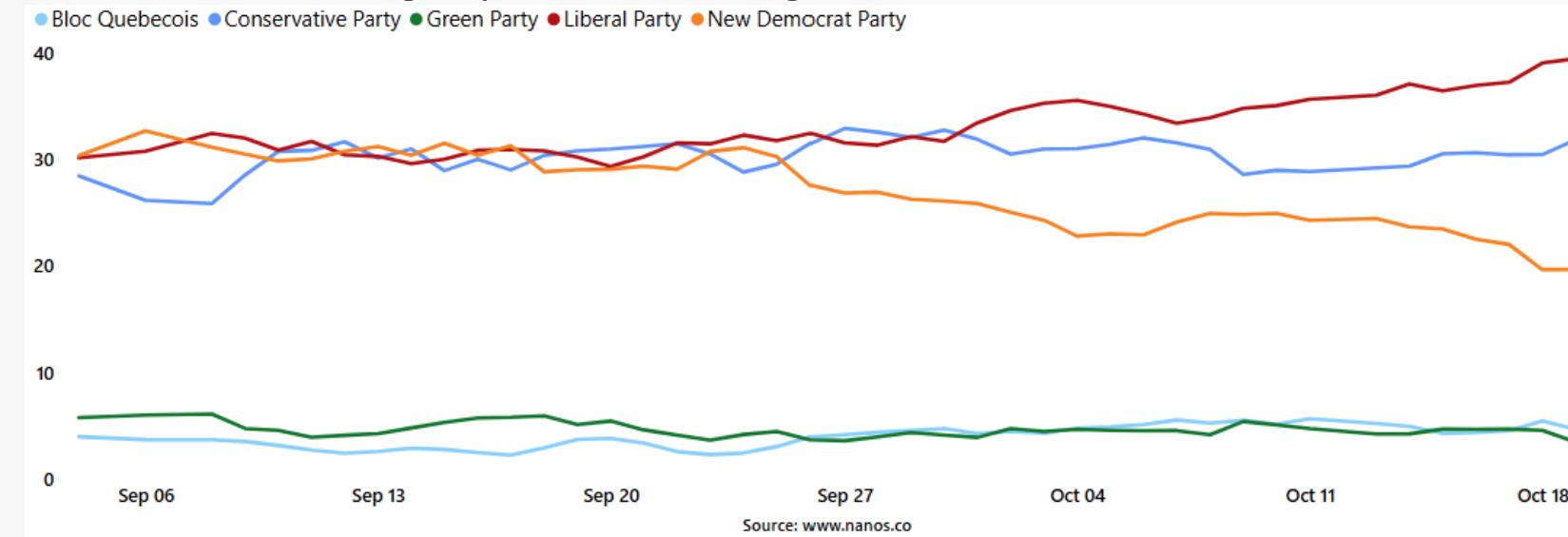

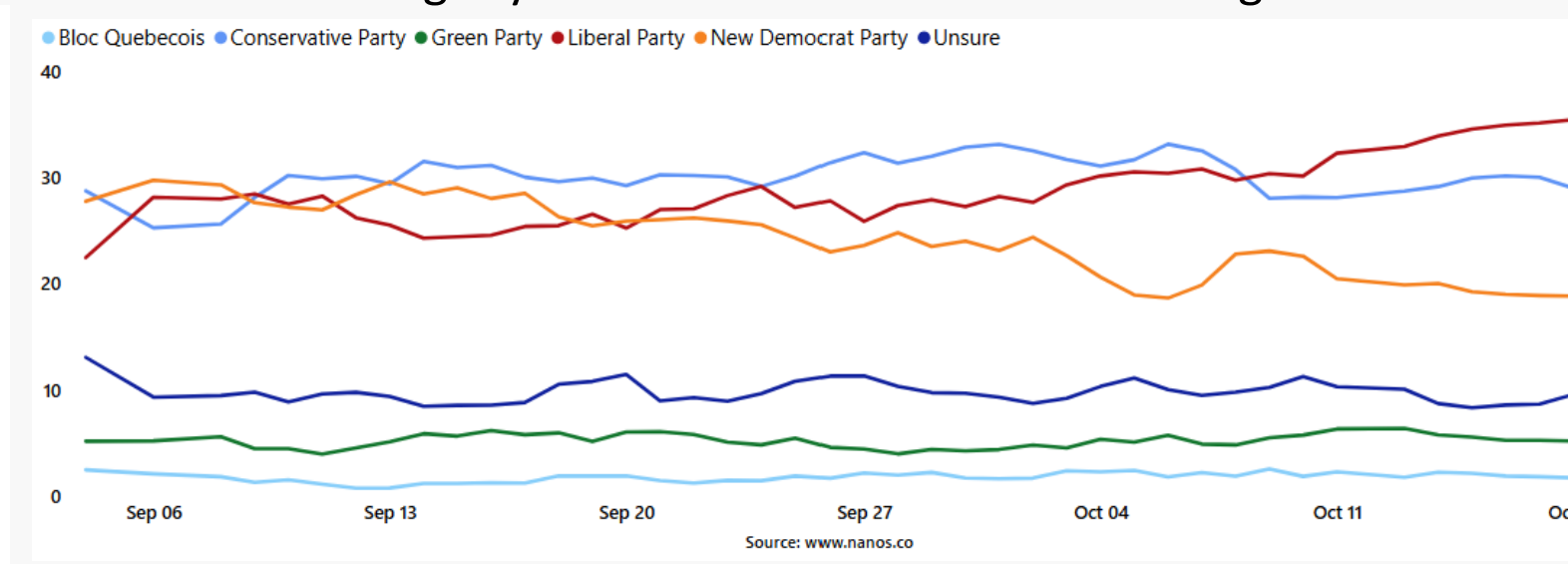

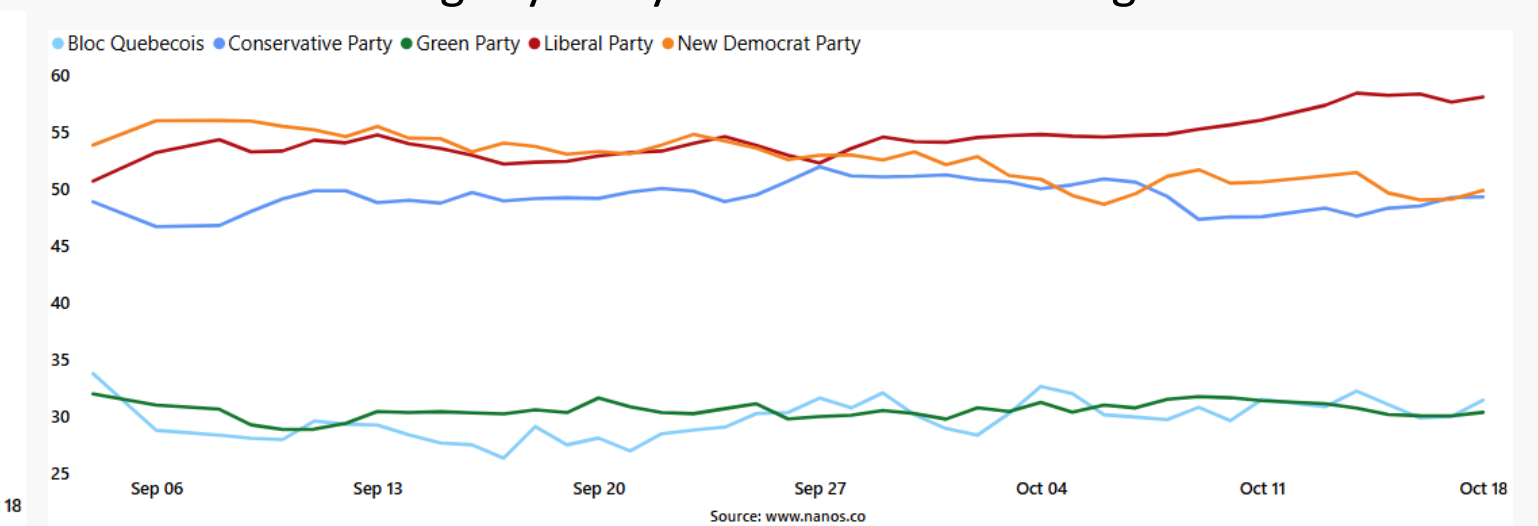
